Improvements such as the extended Christmas decorations and flower baskets have gone a long way to give our town a lift but we need to develop that Town Hall initiative with a corporate approach from shopkeepers, businesses, schools and the Ramsey Chamber of Trade all playing an active part.

> The Department of Trade and Industry need to be flexible in their approach to granting assistance to businesses wishing

> > The problem of Car Parking to meet the needs of those working in the town and those who come to shop has to be addressed. The creation of a multi storey car park at the Plaza site is a positive move towards solving the problems of office workers having long term parking.

> > We need to introduce grants for small businesses to create suitable disabled access and ensure

that our pavements and crossings are accessible to wheel-chair users and the elderly.

I believe that we should have a By-Law Officer permanently assigned to the town to deal with Litter, Dog Fouling and Car Parking offences.

We need to increase the power of local authorities to enforce external upkeep of commercial properties.

## Town Enhancement Programme

#### MULTI PUPOSE ENTERTAINMENT CENTRE

I firmly believe that whatever is developed in Ramsey needs to be for the maximum benefit of the people of Ramsey. The Peveril plot is a site that is enjoyed by the people of the town and I fear that if we are not careful it will be developed into commercial offices and luxury dwellings. This is not going to ultimately benefit the people of Ramsey. I contend that we need the vision to use that area as a recreational lung for the town. People are crying out for a Multiplex centre which can be used by all members of our community and I believe that this should be built on the Peveril plot. Such a complex could encompass exhibitions. Yn Chruinnaght and social functions. It could contain a lecture theatre doubling as a cinema and have sites off the main area that could contain staging for amateur dramatic productions or musical concerts and cultural workshops for art, craft, music and dance. A much needed dedicated youth area could be created together with performance facilities for budding young musicians.

Whilst the earlier Marina proposals were believed to be unacceptable a more modest scheme can still be achieved by developing the Old Harbour. I would seek Central Government funding as has been available to Douglas and is to be available to Port St. Mary and Peel, for the creation of this facility.

# ANNE CRAINE says

"The major issue of concern in our community at the present time is the reduction of medical service available at Ramsey Cottage Hospital. Our hospital is the "lewel in the Crown" of our town, envied across the Island, and we must not allow modern day practices to reduce the service to a poorer provision than available 40 years ago. The cessation of 24 hour accident and emergency provision at "The Cottage" has created an overwhelming fear amongst the elderly in our community who feel particularly vulnerable. Whilst I can accept that GP's no longer wish to operate a 24 hour emergency service a solution must be found. The geographic division of the north from the rest of the Island cannot be dismissed and I believe that we must press for a slice of the MannDoc service to be based in Ramsev and 24 hour doctor led service in Ramsey Cottage Hospital to cover accidents emergencies."

#### FOR:

- Re-instatement of 24 hour doctor led accident and emergency service at Ramsey Cottage Hospital
- Provision of MannDoc Services based at "The Cottage" to serve the north
- Maintaining Ramsey as an attractive option for the recruitment of CP's
- A Health service as befits an Island economically buoyant in the year 2003.

# Schools

I feel disappointment and frustration at the recently announced news that the Department of Education is to delay the



building of the school at Clifton Park until 2007/08. Whilst welcoming the £10 million investment in the two new primary schools in Ramsey, it is infuriating that the delay is being attributed to the consultation with parents and priority being given to the new secondary school at Bemahague.

Albert Road School is well past its sell by date and the children and staff do not deserve to be handicapped by Victorian facilities. A way must be sought to advance this scheme for the benefit of our children. Increasing numbers are putting our staff and facilities under pressure. Fortunately, major building schemes continue at Ramsey Grammar School and the future creation of sixth form accommodation will enhance the provision available.

## **ECONOMY**

The Island's economy needs to continue to grow and diversify to become even more robust, whilst preserving the quality of life that we all cherish. This will be more difficult when economies throughout the world are suffering. In these days of political turmoil the Isle of Man will become a sanctuary to those businesses requiring stable Government. We should turn this to our advantage by becoming more proactive in attracting the right kind of new business to the Island.

We need to defend the Island's national interests against external threats from the U.K., E.U., and O.E.C.D., by the creation of a Ministry for External Affairs which would be charged with seeking allies in other jurisdictions.

More careful scrutiny of Government expenditure is required to ensure we receive value for money in the delivery of all services and Capital projects provided.

# THE RESIDENCY ACT AND IMMIGRATION

Whilst I support the introduction of The Residency Act which Tynwald has passed but not yet implemented is currently pursuing I believe that the threat of illegal immigration needs to be dealt with urgently.
