DAVID CANNAN married with a grown up family has had the honour of being the Member of the House of Keys for the Sheading of Michael since 1982.

I have had 24 years experience of Government including Speaker of the House of Keys (April 2000 - October 2001), Minister for the Treasury (1986-1989), Chairman of the Financial Supervision Commission, Vice Chairman of the Public Accounts Committee and a member of most Departments at some time.

It has been a privilege to have been your Member of the House of Keys and I offer myself for re-election and seek to obtain your support and confidence for a further term in office.

My time is divided between attending to local matters and national issues as well as attending to the many and varied problems of constituents. During the past years I have consistently promoted the well being of the Parishes of Kirk Michael, Ballaugh and Jurby and have been available at all times for people who wish to see me.

LOCAL ISSUES

In matters of the well-being of the Constituency, the following have been achieved during the past five years.

Kirk Michael

- 1 The official opening in January 2002 of the new classrooms and sports hall at the school.
- 2 Provision of a public water supply to the residents of Little London.
- 3 Full public consultation on the proposal for a By-Pass.
- 4 Planning approval in principle and financial provision for the establishment of a General Medical Practice Doctors' Surgery.
 It is my hope that the construction of the surgery can
 - commence early in the New Year. The provision of a full time General Medical Practice Surgery, for the residents of Kirk Michael and surrounding district, will be of great benefit to everybody, and an asset to the village.
- 5 Coastline Management Act giving statutory powers for the protection of the coast between Glen Wyllin and Balleira.
- 6 Statutory notice that the whole of Glen Wyllin and the original village properties and land from the school playing field at Douglas Road Corner to the Whitehouse cottages is now a conservation area. Notwithstanding that Tynwald approved the Conservation Area to take effect from I August 2006, the Department of Education in a letter to me dated 2 October

2006 stated that the sale of the school playing field is still

under consideration and consultation with the Government

Valuer is presently taking place.

It would appear that the Minister (Hon. D. Anderson, MHK) and Department of Education have no regard for the expressed will of Tynwald that the school playing field is a conservation area.

The implications of the school playing field becoming a roundabout and access road to a future 200-300 house housing estate are well known.

- 3 Threshold Estate. Full external decoration later this year.
- 5 NO 2 S S S
- 4 Plots for Sale. Present and future availability on the former Army Camp.
 - Former Army Camp. This area is zoned for residential development and a public exhibition of the housing proposals
- 6 Industrial Estate. Development of small industrial units progressing. £1.3 million approved by Tynwald for the refurbishment of the old hangars. Continuing promotion of Jurby by the Department of Trade and Industry as an attractive location for commercial operations.

For the future, it is my policy that the following will be achieved as soon as possible.

- I Construction of a full time General Medical Practice Doctors' Surgery for the residents of Kirk Michael and the surrounding district.
- 2 Construction of a rock revetment sea defence wall between Glen Wyllin and Balleira to prevent further coast erosion caused by global warming.

I Replacement of the existing portacabin classrooms with the construction of classrooms extension at the rear of the School.

Jurby I Completion of residential development of the former Army Camp and refurbishment and re-development of the Industrial Estate so as to establish Jurby as a viable and sustainable village.

The Government must continue to encourage the development of profitable businesses and the diversification into new activities so as to create a balance between the finance sector and the manufacturing, tourist and agricultural industries.

This Island is not immune from the problems of the outside world and continues to have a great challenge ahead to sustain our prosperity which is the only means by which we can maintain the present expenditure and increasing cost of Health Care, Social Welfare, Pensions, Education and the preservation of Law and Order, etc.

To continue the present economic success the Isle of Man must

I offer experienced and responsible handling of the economy to fulfill the promise of a secure future for all the residents of our Island home.

THE TREASURY

There has to be a determination by the Treasury Minister to ensure Treasury officials oversee every aspect of public expenditure by Departments to ensure competence, financial probity and good management.

HEALTH CARE: Government has an obligation to provide the very best Health

Service to the people of the Isle of Man. To achieve this the funding of the Health Service must be a priority of Government expenditure and this includes financial provision for the restoration of a 24 hour, seven days a week opening of the Ramsey and District Cottage Hospital.

PENSION AND PENSIONERS: Government and the community have a duty to care for our

pensioners. To ensure that there is a standard of comfort during the winter months there is a £400 winter heating payment paid to those pensioners in receipt of Income Support. Elegibility for Income Support is for those pensioners with a disposable weekly income of less than £135 per week. Those pensioners whose weekly income exceeds £135 DO NOT RECEIVE any assistance towards winter heating costs.

It is my policy that pensioners not in receipt of the £400 winter heating bonus, should receive a winter heating payment based on a sliding scale from £400 downwards, depending on income.

SOCIAL SERVICES AND WELFARE:

The continuing provision of existing social services is essential. In the matter of the responsibility for child care and young persons, there is an urgent requirement for more efficient management.

SOCIAL SECURITY:

The continuation of existing benefits in relation to need, continues to be maintained to keep pace with the cost of living.

EDUCATION:

To provide the best education for our children with the ethos based on achievement according to their ability.

To provide a Special Needs Service for disadvantaged children that is in the interests of the children and **NOT** for the bureaucratic convenience of officials in the Department of Education.

POLICING - LAW AND ORDER:

The Police must be supported so that all of us can live peacefully and enjoy quality of life in our beautiful environment.

The Police have a duty to a commitment of efficient and impartial service to the community.

LOCAL GOVERNMENT:

I support continuation of the existing Local Authorities but with positive encouragement to amalgamate with adjacent authorities in the provision of services which would result in efficiency and lower cost to the benefit of the ratepayers.

PLANNING:

This is always a contentious issue but in respect of small applications such as kitchen extensions, garages, etc, there must be more flexibility. Presently there are too many vexatious refusals by the Planning Committee.

HOUSING:

There is a continuing demand for both public sector and private sector housing. Home ownership is to be encouraged but Government has a duty to provide public sector housing for those who do not have the financial resource necessary for home ownership.

At present there are too many persons on the waiting list for public sector housing and a more urgent commitment to new build is required.

SEWAGE DISPOSAL (IRIS):

A very large amount of money, including consultants fees, has been spent on this project to date and the performance has been less than satisfactory.

A serious review of the project is a requirement before any further work is commenced in the West and the North of the Island.

WASTE MANAGEMENT AND THE ENVIRONMENT:

The protection of the Island's environment – this green and pleasant land in which we all live and work – is of primary importance. Recycling of waste is to be encouraged.

In order to have the ability to pay for the above matters, the job creating, income creating business of the Island must always be supported and encouraged by Government.

FINANCIAL SERVICES INDUSTRY:

This is the backbone of the Island's economy and the Island's largest employer supplying a wide range of financial services worldwide. The industry requires full Government support for the promotion of its international business activities and Government protection from any discriminating and adverse legislation and sanctions by such forums as the EU and OECD.

To ensure the integrity of the Financial Services Industry there requires to be a strong Financial Supervision Commission to prevent abuse.

TRADE AND INDUSTRY:

The Island's trade and manufacturing industry require positive and continuing promotion so as to create stronger diversification of the economy.

The cost of electricity and gas need to be carefully monitored. There must be careful supervision on the issue of Work Permits to ensure that illegal immigrants do not enter the Island.

AGRICULTURE AND FISHERIES:

As I have in the past – so I will continue in the future – give my full support to Manx Agriculture and Fisheries. I am fully aware that Manx farmers are facing many problems, not least financial viability and concerns at the loss of the EU meat derogation in 2010. A strong policy of promoting and marketing Manx agricultural and fishery products for both the home market and the UK market is

TOURISM AND LEISURE:

essential.

A more positive approach is needed by the Department to encourage tourism throughout the year and not just to motor sport events.

A positive commitment is required to up-grade the tourist infrastructure to meet the standards and expectations of today's visitor.

GOVERNMENT:

In conclusion, let me clearly state that the policies set out in this manifesto can only be achieved by a strong Government that has the support of the people and the will to govern.

Pivotal to the good Government of the Island is the election of a Chief Minister who then appoints his Ministers.

CONSTITUTION:

To establish a Government that is fully democratic and has the confidence of the people it will be necessary to reform the

Legislative Council and have a 32 seat Tynwald – all elected at a General Election – together with a Chief Minister, similarly elected at the General Election.
