# **Election Issues**

#### Rates

Onchan has historically maintained low rate increases and I am disappointed therefore that this tradition has this year been broken. I am opposed to any further excessive rate increases. I have always advocated rate payers money should be wisely spent without unnecessary cost cutting and I will continue to work towards achieving this if I am elected.

Targets and objectives need to be set in order to achieve prudent spending which those elected to the next board will need to prioritise.

#### Commissioners

The election in Onchan this time will see a reduction in the number of Commissioners by three members from ten to seven.

The Rural Commissioner and Urban Commissioners for the first time will be elected by the whole of the Onchan electorate. Every Commissioner under the reorganisation will now, I am pleased to say, attend every meeting which has not been the case under the past committee system. Elected members should always exercise their vote.

# Law and Order

The Commissioners have appointed a Community Warden who works well with the police in addition to carrying out duties in the District on behalf of the Authority.

Onchan has a new Police Inspector who has a different approach, which I am sure will benefit the Community in every aspect of policing. Regular meetings are essential to share information and address problems. Good policing is an important part of community life to eradicate crime and public order offences. Police foot patrols, now reintroduced, will reassure the public who can communicate with their local officers on an informal basis. I support the retention of a manned Police Station in Onchan and the increase in Neighbourhood Watch schemes. Street Lighting and affordable CCTV initiatives, where necessary, are good crime prevention measures. Provision has been made for extra street lights along with enhanced lighting at some existing locations.

The Commissioners have provided recreational facilities and a drop in centre for the youngsters of the village. Organised sporting activities should be encouraged. "Sport keeps kids out of court".

# Housing

I recognise the need for all aspects of housing and have been mindful of the needs of others throughout my time with the Commissioners.

Building land is in short supply in Onchan and thoughtful consideration has to be given to the type of properties which can be constructed and which complement existing dwellings. The Commissioners have opposed housing developments on the Birch Hill farm land which has been rejected at a planning inquiry, a measure I support. Local Authority housing maintenance needs to be kept in line with rent increases in order to provide modern standards of living.

# **Education**

I believe building work on the proposed new secondary school for Onchan will commence early in 2009 which will complement our two excellent primary schools.

## **Roads and Pavements**

Onchan has the second largest community population. Roads, pavements and street furniture need to be well maintained.

# Traffic

The whole of the Isle of Man experiences traffic and congestion problems at peak times of the day. The road improvement scheme at Governors Bridge should help to relieve congestion and make traffic flow easier. The "Smiley Face" speed reduction traffic signs need to be used more often. I support improved legislation to address inconsiderate parking of large vehicles and trailers in the District along with greater enforcement of the present laws.

## **Amenities**

We have an excellent Doctors Surgery in the Village Walk. A petition has been presented for the removal of the radio masts from the surgery roof, which I support. A new Dentist Surgery is soon to be opened in the Village Walk. The Library is a credit to Onchan and is regularly used by adults and children of all ages.

Recreational play areas in the District have been up-graded with new equipment. A Nature trail is under consideration at Groudle View. The Village Green is an excellent venue for social events. Port Jack Glen has been enhanced.

## **Onchan Park**

Onchan Park is our main asset and a feasibility study is planned to see if facilities can be improved, although major changes should not be made simply for the sake of change. Leisure activities are enjoyed by people of all ages in Onchan Park. I have to say I was disappointed the at opportunity for the provision of a Velodrome Cycle track when Nivision Stadium was put out to tender last year. Financial support would have been provided from outside organisations. I believe the facility would have been an important asset to the Village and the Island as it would have provided various sport and training facilities for youngsters together with health promotion programmes for adults.
